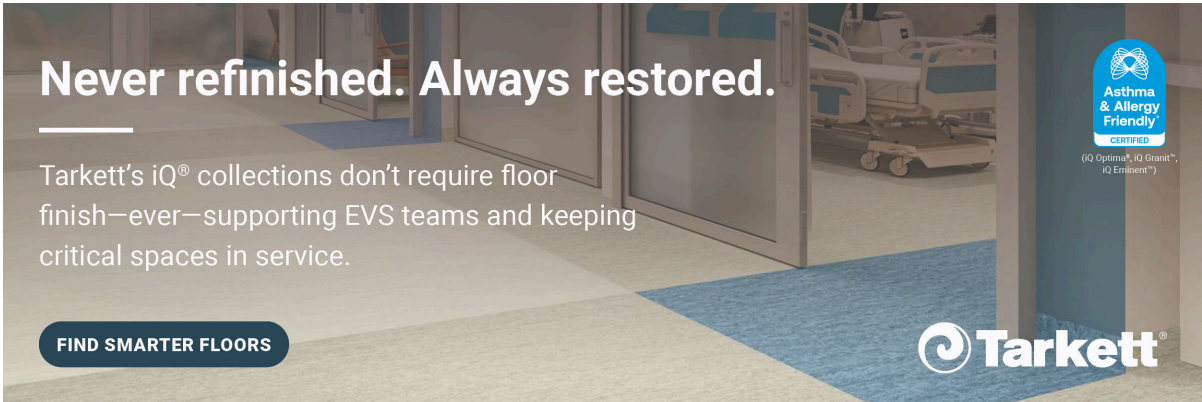

Biggest MOB Deal Ever: \$7.2B

In a transaction officially announced Oct. 27, the longstanding partnership of Chicago-based Remedy Medical Properties and Boca Raton, Fla.-based Kayne Anderson Real Estate acquired a majority ownership interest in a portfolio of 296 medical outpatient buildings with more than 18 million square feet of space from one of the sector's longest-standing players, Toledo, Ohio-based Welltower Inc. The price makes the deal the largest arm's-length transaction in the history of the MOB space.

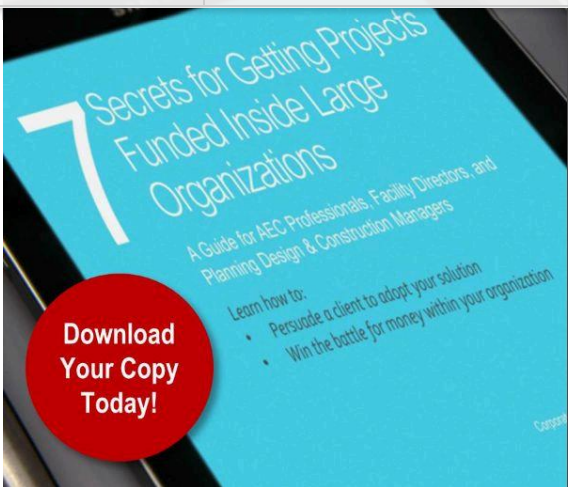
